An Examination of its Past and Future

Karl Louis is managing director of Corinphila Auctions; An expertizer with the BPP (Bund Philatelistischer Prüfer e. V. / Association of Philatelic Examiners, a German expertizing organization); and AIEP (Association Internationale des Experts en Philatélie / International Association of Philatelic Experts); a Fellow of the RPSL, and member of the Collectors Club of New York.

Karl developed an incredible and widely utilized database containing over 60,000 Great Britain entries and has made many contributions as a scholar and author to the *Fakes Forgeries Experts Journal*; the FgGB (Forschungsgemeinschaft Grossbritannien e. **Council of Northern California Philatelic Societies**  
**Minutes of 11/6/10**

The 3<sup>rd</sup> meeting for 2010 of the Council of Northern California Philatelic Societies was called to order by President David McNamee at 12:07 pm on November 6, 2010 in Sacramento. All current officers were present as well as representatives from 6 clubs. The minutes of the Reno meeting in August were dispensed with as a lack of quorum precluded any business.

President David McNamee announced that he had received resignations from Bill Lenarz, Council Secretary, effective 19 October, and Frank Scudero, Council Treasurer, effective 4 November. The President may make appointments to fill vacancies on the Board, and anyone having a desire to serve the Council can apply for either of these positions. Immediate Past president Vesma Grinfelds has signing authority over the checking account, and temporarily the Council will manage that way. President David McNamee and VP Daryl Reiber should be added to the account as soon as practical.

The Secretary position being vacant, notes of this meeting will be kept by the President with assistance from Vesma Grinfelds.

David McNamee distributed a spreadsheet prepared by the Treasurer showing that 2 of 35 member clubs had still not paid their dues. There is some doubt if these clubs are viable; however, discussion supported retaining them in the roster in order to promote philately, in spite of their failure to contribute their dues. Also distributed was the most recent Treasurer's Report for the period ending 11/4/2010.

Vice President and *Council Courier* Daryl Reiber announced that the next issue would be forthcoming in two weeks. He stated that he had a lot of information compiled since the last issue in February.

The Judges Committee made its report. We are in the process of filling slots for the coming year. We have one new judge and one new apprentice, and we are always looking for more apprentices to train as philatelic judges.

The Awards Committee made its report. Vesma Grinfelds showed off the new Holmsten Award plaque, to be engraved with the name of the winner of the Grand Award at the designated Council Show (SACAPEX this year). The Chaloner Award recipient has also been selected, and that will be announced in due time.

The Frames Committee gave a report on the state of the frames noting some water damage has taken place at an unknown time and place. Plastic sheeting has been purchased and placed in the supplies box to protect them in future during rainstorms.

President David McNamee appointed Vesma Grinfelds and Daryl Reiber to the Nominating Committee as well as himself. The nominations are open to any member of a Club Member, including self-nominations. Daryl will see that appropriate coverage is published in the *Council Courier*. Nominations close at the October Meeting 2011 (EBCC Show) and elections take place at the December meeting 2011 (PENPEX).

A general announcement was made concerning the attempt to restart COALPEX and the need for a show in June on our annual schedule.

The next meeting is scheduled for the WESTPEX show at 1:00 pm on Sunday, May 1, 2011. Subsequent 2011 meetings will be at the EBCC show and PENPEX, specific dates and times to be announced.

SACAPEX and the Sacramento Philatelic Society were thanked for their hospitality in hosting the Council meeting. The EBCC Show in October 2011 was chosen as the designated Council show for next year. The meeting was adjourned at 12:51 pm.
